Last Wednesday (10th July 2024) President Kiir of South Sudan issued a number of presidential decrees, two of which affected the Ministry of Petroleum (MOP). The current undersecretary Dr Deng was replaced by Dr Thon and Dr Lino was made the new CEO of the state oil company Nilepet.
